The Jackson Parish Clerk of Court Web Inquiry Website is used to research records information. The following type of information can be gained with this tool

- Marriage
 - Marriage Index Records Researched by
 - Bride Name
 - Groom Name
 - Maiden Name

- Property Records
 - Mortgage Index Records
 - Conveyance Index Records
 - Oil & Gas Index Records
 - Charter Index Records
 - Plats Index Records
 - Bond Index Records
 - Oath of Office Index Records
 - Miscellaneous Index Records
 - Notice of Candidacy Index Records
 - Notarial Adoption Index Records
 - Court Rule Index Records

On some of these types of records, you will also be able to view scanned images of the documents.

Logging In

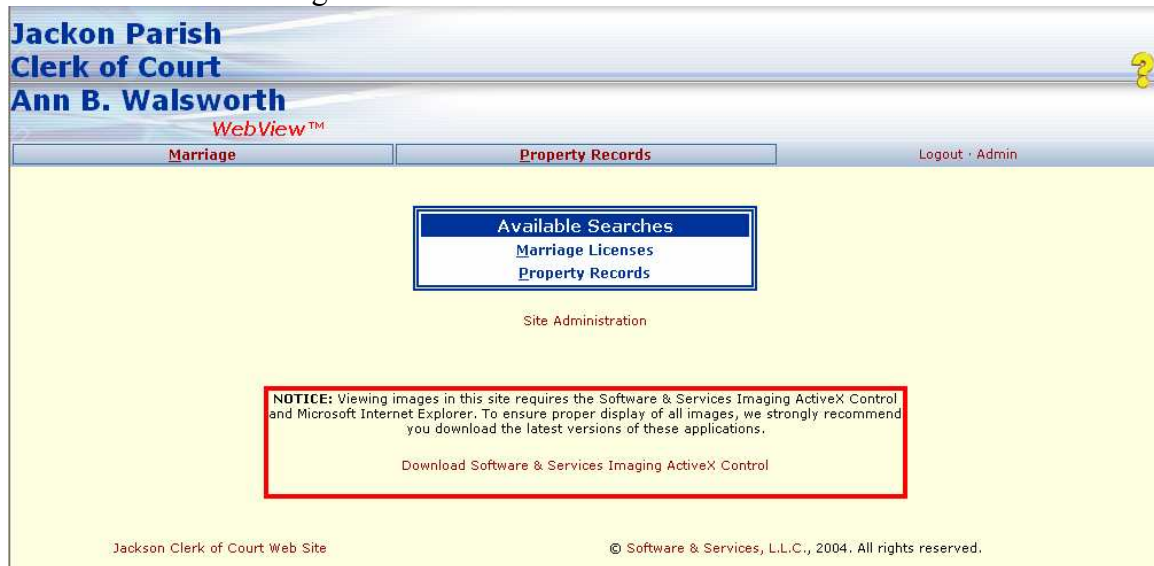
To log in to the Jackson Web Inquiry Website, you must have a login and password assigned to you by the Jackson Clerk of Court Office. If you do not have one, please contact the Jackson Clerk of Court’s Office at (318) 259-2424. If you have entered this inquiry screen by accident, press the Jackson Clerk of Court Website to return to the Jackson Parish Clerk of Court Website.

1. Enter you login name in the Username field
2. Enter you password in the Password. The password will be screened with “*”.
3. Click “Login” or press <Enter> on your keyboard.
4. Once you have logged in, you will be transferred to the Available Search screen to begin your research.

Performing a Marriage Search

The Marriage Search will allow you to review marriage indexes to provide information for further research on marriage license information. You can get to the Marriage Search screen through three methods:

- Press <Alt> + <M> on your keyboard
- Click on the “Marriage” toolbar button
- Select “Marriage License” on the Available Searches screen.



Once you have selected the Marriage option, you will be transferred to the Marriage Search Screen. You have three ways to search for marriage license records.

- Search by Bride, Groom, or Maiden Name
- Search by Book & Page
- Search by Registry (Marriage License) Number

Performing a Property Records Search

The Property Records search allows you to search indexes of records pertaining to Mortgage, Conveyance, Bond, Notice of Candidacy, Chattel, and Miscellaneous Records. You can get to the Property Records Search through three methods:

- Press <Alt> + <P> on your keyboard
- Click the “Property Records” toolbar button
- Select “Property Records” on the Available Searches screen.



Once you have selected the “Property Records” option, you will be transferred to the Mortgage and Conveyance Search Screen. You have two ways to search for records in this category:

- Search Mortgage and Conveyance By Name
- Search Mortgage and Conveyance By Instrument Number
